1 Introduction

Keesing Reference Systems B.V. takes your privacy very seriously. This policy contains important information about what to expect when Keesing Reference Systems B.V. collects personal information about you and how we will use your personal data. 2 The information we collect about you in *.Documentchecker.com

When you do business with us, register for our service(s) Keesing Reference Systems B.V. may collect the following personal information from you:

- Account name, Full account name, Password, IP address
- E-mail address

3 Machine Readable Zone Checker

With this tool you can check the Machine readable zone of an ID. To check a MRZ, you need to enter Machine Readable Zone (MRZ) Code in the boxes. Depending on the document type the MRZ contains 2x44, 2x36, 3x30 or 1x30 positions.

When you click on the 'Check' button, the MRZ provides the outcome of the check. It's also optional to check: Date of birth and/ or date of expiry. **Please note:** The Machine Readable Zone Checker algorithm calculates only the MRZ. Data is stored temporarily. When the tool is closed, all data will be automatically removed.

4 Standard users access via IP address recognition

We may collect your IP address for system administration. Standard users enter the application directly via IP recognition. Once the account is activated, the user can access to Documentchecker via IP address.

5 Super User access through username/password authentication

Once you have received notification via e-mail that your account has been activated and have received your login details for the Super User account you can access the databases directly through: www.documentchecker.com

6 Internet browser settings and Cookies

Our website uses cookies. Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information.

We use analytics cookies to collect information on how visitors interact with our website and to enable us to maintain and develop it.

7 How we protect your information

We store all information you provide to us on our secure servers. Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, from that moment on we are responsible for the data.
